The regular meeting of the Board of Directors of the Durham Recreation and Park District was held on Thursday, January 13, 2022. Chairperson Goepp called the meeting to order at 5:30 pm. Directors Bradley, Stevens and Hayes were present. Also in attendance: Kelley Parsons-District Manager, Kirsten Cyr-Administrative Manager. Stevens opened the meeting with the Pledge of Allegiance.

- 3. Request Approval to move May's board mtg. to May19-Kirsten will be on vacation first 2 weeks of May-Hayes made the motion to approve moving May's board mtg. to May 19th. Stevens seconded it passed 4-0 with Bradley, Hayes, Stevens and Goepp all voting in favor.
- **4.** Request Approval of MOU with DUSD-Midway Park.-Parsons worked with the Superintendent on the wording. In order to install the new ballfield at Midway, the MOU needs to be approved by both boards. Stevens made the motion to approve the MOU. Hayes seconded it passes 4-0 with Hayes, Goepp, Bradley and Stevens all voting in favor.
- **5.** Request Approval of Audit for Years 2020 & 2021-Bradley made the motion to approve the Audit for years 2020 & 2021. Hayes seconded and it passed 4-0 with Goepp, Hayes, Bradley and Stevens all voting if favor.
- **6.** Request Approval of Bid for Pool Roof Replacement- The women's restroom skylight is leaking water due to the roof needing replacement. Parsons recommended we go with the bid from Johnson Roofing to replace the entire roof. Bradley made the motion to accept the bid for Johnson Roofing and replace the entire roof. Stevens seconded it passed 4-0 with Hayes, Goepp, Stevens and Bradley all voting in favor.
- 7. Appoint Committee to select a new Board Member-Parsons let the board know we have extended to date for community members getting us their letter of interest until January 31, 2022. We have posted around the community, and we will send out an email announcement this week. There will be an online application on our website this week as well. Parsons let the board know that we do not need a special committee because the board applicants will be interviewed by the whole board.
